### **CONTEXT**

The 2030 Agenda (SDG 1.3) outlines a clear commitment to "implement nationally appropriate social protection systems and measures for all, including floors, and by 2030 achieve substantial coverage of the poor and vulnerable". But with only six years to 2030, less than half the global population have access to social protection. Fewer than 1 in 10 children in low-income countries have access to child benefits, a figure which is 10 times lower than for those living in high-income countries.

We are failing.
